#### Code of Conduct for Members

As a member or co-opted voting member I have set out below the **Disclosable Pecuniary Interests** (Part A) and the **Other Registrable Interests** (Part B) and Gifts and Hospitality (Part C) which I am required to disclose under the council's Code of Conduct for members and co-opted voting members, and I have put "none" where I have no such interests under any heading.

**"Disclosable Pecuniary Interest"** means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Part A of the Table below.

**"Partner"** means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

**Other Registrable Interest** means an interest as set out within the descriptions set out in Part B of the Table below.

**NOTE:** Members and co-opted members must register Disclosable Pecuniary Interests and Other Interests with South Gloucestershire Council's Monitoring Officer within 28 days of the election to office.

Contracts	<p>You must disclose details of</p> <p>Any contract made between the you, your spouse or civil partner or the person with whom you are living as if you are spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director<sup>1</sup> or a body that such person has a beneficial interest in the securities<sup>2</sup> of) and the council —</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>		
Land <sup>3</sup> and property	<p>You must disclose details of:</p> <p>any beneficial interest in land which is within the area of the relevant authority.</p>		
Licences	<p>You must disclose details of:</p> <p>licence (alone or jointly with others) to occupy land in the area of the authority for a month or more.</p>		

<sup>1</sup> 'director' includes a member of the committee of management of an industrial and provident society.

<sup>2</sup> 'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

<sup>3</sup> 'Land' excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners (alone or jointly with another) a right to occupy or to receive income.

Corporate tenancies	<p>You must disclose the details of:</p> <p>any tenancy where (to your knowledge)—</p> <ul style="list-style-type: none"> <li>(a) the landlord is the relevant authority; and</li> <li>(b) the tenant is a body that you, your spouse or civil partner or the person with whom you live as if they were spouses/ civil partners is a partner of or a director* of or has a beneficial interest in the securities* of.</li> </ul>		
Securities	<p>You must disclose details of:</p> <p>Any beneficial interest in securities of a body where—</p> <ul style="list-style-type: none"> <li>(a) that body (to your knowledge) has a place of business or land in the area of the relevant authority; and</li> <li>(b) either— <ul style="list-style-type: none"> <li>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</li> <li>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in</li> </ul> </li> </ul>


PART B	Other Registrable interests		
	<p>You must register as an Other Registrable Interest:</p> <ul style="list-style-type: none"> <li>a) any unpaid directorships</li> <li>b) any body of which you are a member or are in a position of general control or management and to which you are nominated or appointed by your authority</li> <li>c) any body <ul style="list-style-type: none"> <li>(i) exercising functions of a public nature</li> <li>(ii) directed to charitable purposes or</li> <li>(iii) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)</li> </ul> </li> </ul> <p>of which you are a member or in a position of general control or management.</p>		

PART C	Gifts and Hospitality	
	<p>any gift or hospitality with an estimated value of at least £50 within 28 days of its receipt.</p> <p>any gift or hospitality with an estimated value of at least £50 or totalling £100 over a year from a single source that I have been offered but have refused to accept within 28 days of the offer.</p>
